## Volunteer Code of Conduct

1. No physical contact with minors.
2. Never be alone with a minor. Always have another Eden Mill adult volunteer present or the child's parent.
3. During an Eden Mill water-based activity, PFDs must be worn by children 12 and under when within 10 feet of the water.
4. Be aware of emergency procedures and weather.
5. To work with or handle live EMNC animals, volunteers must have completed our live animal training.
6. Dress appropriately as an Eden Mill representative and for the job at hand.
7. When involved in activities, please park your personal vehicle by the tool barn or in the lower parking lot by the pavilion.
8. Exhibit a positive can-do attitude, staying open to feedback.
9. Constantly be aware of park visitors and their actions.
10. Use reasonable judgment for decisions made in the absence of an established policy. Then notify the office as soon as possible for future guidance and clarification.

## Background Verification Information

All Harford County recreation councils are required to implement a background check policy. All volunteers and programmers, age 18 and over, must complete and pass the online background check through *Active Screening*.

A person must complete the online background check process when they complete the initial volunteer application. To continue volunteering, a person must complete the process approximately every two years starting in January of the 2<sup>nd</sup> year following the initial background search e.g. if the initial date of the background check was April 1, 2017, the next required search would be January 2019, then January 2021, etc. The cost for each background check is \$7.95.

If you choose to decline the background check or you do not complete and pass the background check, your application and request to become a volunteer will be denied.

*Active Screening* conducts the background checks and serves as the repository for all results. Eden Mill Nature Committee Inc. will not receive any details of a criminal background check, only a notification of approved or not approved to volunteer. *Active Screening* is the site used by numerous organizations throughout the area. Contact Active Screening to identify the actual process used to protect information.

Disqualifying factors on pending convictions and/or arrests for the following:

Sex offenses and misconduct	Felonies (other than sex or violence related) within the past ten years
Child abuse or domestic violence convictions	Misdemeanors within the past seven years
Violent felonies
