Activity

Utilizing the vast array of resources at Eden Mill, scouts can learn about nature, earn a badge, and have fun during our hands-on programs or guided nature hikes. Most nature related badges can be completed or started at Eden Mill. When scheduling your program, please provide us with any badge requirements you would like to achieve.

Activity Price/Length

Scout programs are typically 1.5 hours long and cost \$5.00 per person per program, with a minimum of \$50 per program. The minimum fee is required to hold your reservation and must be received **within one week** of reserving the date. This is a non-refundable deposit unless we must cancel due to inclement weather. **The remaining balance is due at the start of the program, no exceptions. Siblings and excessive adults WILL be charged the \$5.00/person.**

Preparation for the Participants Attending

Please remember that Eden Mill is a park and participants may get wet or muddy, so please dress accordingly. No opened-toed shoes or sandals. We recommend that each scout bring a water bottle.

A scout leader and 2 adult chaperones only are allowed to stay with the troop during the duration of the program. This program is for the scouts and the program is hindered with excessive adults, especially on a guided hike. **Siblings and excessive adults (above 3) WILL be charged \$5.00/person.**

Release Forms

All group members, including adults, must have an Eden Mill release form completely filled out prior to the program. The adult release form is page 2 and the minor release form is page 3. Please turn in all release forms in one stack to the Eden Mill staff member upon arrival. It is the scout leader's responsibility to insure that all participants have completed release forms before the program begins.

When arriving to Eden Mill, please **park in the lower lot** by the pavilion. Please follow the paved pathway up to the nature center.

PLEASE READ CAREFULLY

In consideration of Eden Mill Nature Committee, Inc. furnishing services and/or equipment to enable me to participate in Eden Mill Nature Committee, Inc. activities, I agree as follows:

As such, other liabilities, hazards and dangers that are integral to recreational activities and/or use of equipment, I hereby assume all liabilities and dangers.

The above agreement shall be binding on my heirs, successors, assigns, administrators and executors.

The venue of any dispute that may arise out of this agreement or otherwise between the parties to which the Eden Mill Nature Committee, Inc. or its agents is a party shall be Harford County, Maryland.

Unless otherwise indicated in writing at the time of registration, photographs of participants may be taken while participating in the program activities for use in publications. No personal information other than the participant's first name will be released under any circumstances.

PARENT/GUARDIAN PERMISSION FORM

I fully understand and acknowledge that: (a) liabilities and dangers exist in my child’s use of Eden Mill Nature Committee, Inc. equipment and my child’s participation in Eden Mill Nature Committee, Inc. activities which may result in injury, illness, death or damage to personal property caused by other participants, by accidents, or by the forces of nature or other causes, (b) liabilities and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, selection of trail or river route, water level, weather conditions, liability of falling out of a canoe and such other liabilities, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment and I hereby accept and assume these liabilities and dangers for myself and on behalf of my child participating in such activities.

I have been advised that my child must wear an approved personal flotation device at all times while on the water. I affirm that my child will not be under the influence of alcohol or controlled substance, and will not carry, use or consume these substances before or during her/his scheduled Eden Mill Nature Committee, Inc. activities. Any claims or dispute arising from my child’s participation in Eden Mill Nature Committee, Inc. activities or use of their equipment shall have venue exclusive in Harford County, Maryland.
